Please note that the branch name of "Tsudanuma" is specified for salary transfers and fund transfers from Monday, August 1, 2011. 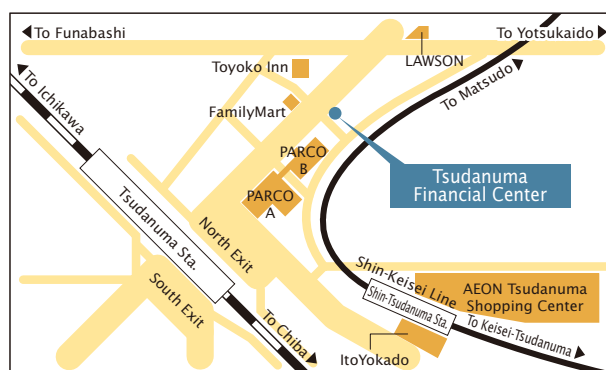

# Closure of LaLaport Financial Center and name change of Tsudanuma Consulting Spot

### Branch name, branch code, and account number

The branch name will become "Tsudanuma" effective Monday, August 1, 2011.  
The branch code remains "430". The account number remains the same.

### Receiving fund transfers

Please inform possible fund senders of **the new branch name, "Tsudanuma", which becomes effective Monday, August 1, 2011**, in order for the funds to arrive at the account successfully. From Monday, November 7, 2011 fund-transfer requests specifying the "LaLaport" branch will not be accepted. From Monday, August 1, 2011 to Friday, November 4, 2011\*, fund-transfer requests specifying the "LaLaport" branch can be processed by regarding "LaLaport" as "Tsudanuma".

\*The funds must arrive at Shinsei Bank not later than Friday, November 4, 2011.

### Salary transfer

Customers who receive their salary in the accounts with the LaLaport branch are requested to ask their company to **change the branch name to "Tsudanuma" after Monday, August 1, 2011 but before Sunday, November 6, 2011**.

### Fund transfers from overseas and domestic fund transfers in foreign currencies

The address of the Tsudanuma Financial Center, which is noted below, will be specified when the funds from overseas or foreign currencies from other domestic financial institutions are transferred to the accounts with the Tsudanuma branch from Monday, August 1, 2011.
